

## GENERAL INFORMATION

**CONDITION™** is a unique, superior water conditioning system that contains almost a pound of ammonium sulfate (dry) for every quart of product. **CONDITION™** also contains water conditioning agents that make calcium, magnesium, and iron unavailable to complex with the pesticide. **CONDITION™** keeps droplet moist longer, increasing the time available for chemical uptake. The 2.5 package of **CONDITION™** contains a proprietary defoaming system that significantly reduces foaming.

**CONDITION™** is recommended to be used at 1 to 4 pt/100 gal (0.125 to 0.5% of the spray volume).

## MIXING DIRECTIONS

Unless directed otherwise by pesticide label, add **CONDITION™** first and agitate to allow dispersion before adding other ingredients. Add pesticides and fertilizers as directed by their label or in the following sequence if not specified:

1. Compatibility agents, AMS, water conditioner, and antifoam
2. Dry flowables and water dispersible granules
3. Wettable powders
4. Flowables
5. Water-based solutions
6. Emulsifiable concentrates
7. Surfactants and other spray adjuvants
