CONTROL DUO LS™ contains the research and field proven **CONTROL WM™** polymer blend in combination with a unique and highly effective surfactant system. The **CONTROL DUO LS™** lowers the production of driftable fine spray droplets compared to most surfactants.

CONTROL DUO LS™ may be used in aquatic applications at labeled rates.

Recommended rates of **CONTROL DUO LS™** are 1 to 6 qt/100 gal for ground applications and 2 to 8 qt/100 gal for aerial applications. Use 6 qt/100 gal with products that contain dicamba and 2,4-D.

Always agitate when adding any product to the spray tank.
