

## GENERAL INFORMATION

**VISION PINK™** concentrated dye is designed to be used in spray pattern testing, research studies, and with agricultural foam marking concentrates. **VISION PINK™** colors the respective solutions a bright pink that fluoresces. This allows analysis of the string on fluorometer equipment used by S.A.F.E analysts or any other research needing a stain or fluorescence in the solution. The pink color significantly increases the visibility of the spray or foam and fluoresces when exposed to UV-light, such as in sun or black light.

## USE DIRECTIONS

Use **VISION PINK™** at 8 to 32 oz per 100 gal. A rate of 8 to 16 oz per 100 gal is usually enough; higher rates of 18 to 32 oz per 100 gal will help ensure results.

**Note:** Water which has a high minerals content may have an effect on the color concentration needed for a specific application. The rate of **VISION PINK™** may be adjusted to reach the desired color strength. Bleach or other dye degrading compounds may affect the ability of the dye to perform as desired. **VISION PINK™** is not a food additive. Do not use on food crops, for recreational purposes, or other off-label uses.

## STORAGE

Store **VISION PINK™** in plastic containers and protect from freezing. If product should freeze, bring to room temperature and stir thoroughly.
