Application	Rate oz/100 gal
Ground Depending on nozzle, setup, and spray mixture	1 to 5
Airplane Depending on nozzle, setup, speed, and spray mixture	2 to 8
Helicopter Depending on nozzle, setup, and spray mixture	1 to 4

- 1. Factors that influence the optimum rate of CONTROL WM™ include spray mixture components, pressure, nozzle type, application method, speed, and proximity to sensitive non-target areas. Use the higher recommended rates of CONTROL WM™ when applying mixtures or under conditions that reduce spray droplet size, and when mixing with 2.4-D and dicamba.
- 2. If additional drift reduction is needed, increase the rate of **Control WM™** until the desired effect is obtained.
- 3. May use in aquatic applications at labeled rates.
